

Certification FAQ's

Q: Are the certifications that The Crawford Group does, the same as the ones that Lominger offers in Minneapolis ?

A: Yes...and no. Yes, because we all use the same materials, the same presentations, and cover the same research and key points. The “no” is because The Crawford Group is here in sunny southern California and there is no way that you can say that is the same as Minneapolis. Also, the facilitator, Lisa Crawford was an early Leadership Architect® customer before she became a Lominger Associate/consultant - and because of that, she is really interested in helping you with the implementation of the tools in your organization once you leave the training class...so she spends a lot more time on the how's of implementation and also helping you explore some of the issues you are likely to encounter when you do implement the tools in your organization.

Q: If I already have some of the materials that are used in the certification I sign up for, do I have to buy them again ?

A: No, but you'll need to call or email us before we order your certification materials and tell us what you already have...and as long as the ones you have are the most recent versions of the materials used in the class, you won't have to buy new ones...but you WILL have to bring those materials to the certification class with you so you can use them in the class.

Q: Where are your certifications held?

A: We hold most of the certification classes and workshops in a fabulous boutique hotel in Carlsbad. The West Inn and Suites (luxury without luxury prices) They have a perfect conference room where we hold the classes and the hotel itself is lovely... everyone who comes in from out of town to attend a class has raved about it. It has fabulous accommodations, is close to the beach, outlet shopping and lots of restaurants. And you might not know, but there is an airport right in Carlsbad. If you fly on United Airlines, you can take a short flight from LAX and fly right into the Carlsbad airport (airport code CLD) which is about 7 minutes from the hotel. But be sure to double check with us about the training location before you make your hotel arrangements, since we may have to use another facility due to either the size of the training class or meeting room availability.

Q: All the certifications seem to have lots of materials, but I'm flying there from out of town and there's no extra room in my suitcase... will I be able to ship my materials to myself at home or my office - rather than carrying them?

A: Yes, you will. If you have a UPS or FedEx account, just bring along a mailing label with you account number on it, and we'll ship your materials home for you.
